- * All abstracts (proposals) are reviewed and the accepted papers will be published in a reviewed book. The book will be printed after the conference and will include only the papers presented at the conference.
- * Authors of accepted papers are required to register for the conference, pay the annual COPE membership dues and publication fee.
- * The completed paper is limited to 15 pages.
